# FROM THE PRESIDENT'S DESK



#### New premises update:

We had a meeting wth Uniting recently, they are proceeding with their work and they still say we have 12 months from now before the bulldozers arrive.

We asked Waverley Council if we could move into the now empty Bondl Rd Council Chambers until they have approval to re develop the site or use it in some other way but they have said NO. We have asked Waverley Council for other sites but nothing is available.

**Randwick City Council** have offered us a permanent/long term purpose built facility down near their proposed SES site on Bunnerong Rd (near the container terminal) but it is awaiting designs, finance and approvals, a process that will take years. We asked Randwick City Council if we could use the Inglis Stables temporarily, until the building site at that SES project is available but they informed us that it is already spoken for.

We then asked Randwick City Council for a site, even if it was just land and temporary, and they replied that there is a possibility that we may be able to occupy the old tennis courts near **Totem Hall and Popplewell Park in South Coogee**.

The site is convenient, it is big, it is level, it has parking, it is on a bus route; how could there be better?

We are now working on finding demountable buildings or equivalent that we can out on the courts and will proceed to seek the approvals and finance to make this our home till the building beside the SES is available some time hence.

These are favourable developments, but, to quote Winston Churchill "Now this is not the end. It is not even the beginning of the end. But it is, perhaps, the end of the beginning."





### COPYRIGHT AND OUR NEWSLETTER

As members are aware, I often get down on my knees begging for material for Scuttlebutt. In response, I often get what is blatantly plagiarised copyrighted articles.

By that I mean that the article (or picture) is copied directly from printed material either directly from the Net or as directed to the member from some friendly source.

Copyright laws are there to protect the creative person who has brought into existence an original work, be it artwork, something written, a photograph, etc.

So that cartoon you received from a friend and thought to be funny may be copyright. Even stuff you found on YouTube is most probably copyright.

So, even if you are skilled enough on a computer to "screenshot" a video you could be breaching the law.

Things you create yourself are your copyright and if you claim the protection of copyright, it is protected by law. You will see our claim for copyright on the front page of Scuttlebutt.

We have special arrangements with fellow Men's Sheds to use each others' material by acknowledging the source and the author, but this must be arranged in advance.

Many photos and articles are out there in the "Public Domain", they are fair game, but acknowledgement is still necessary. Sometimes articles for community benefit are "fair game".

<u>What is the significance?</u> As Editor of another newsletter I recently copied an article by arrangement, and my Club's newsletter was placed on the Club's website for the benefit of members (thus "publishing" it).

In doing this, I was not aware that the other newsletter's editor used copyrighted photos. I was in error as I didn't do the check myself and relied on others.

There are groups out there that do nothing else but search the internet for copyright breaches, which they then report to the rightful owner and claim a very substantial commission from damages that are recovered.

That little exercise over 2 copyrighted photos cost my Club over \$500.00 in damages, mistake is no defence.

This is not intended to be a lesson in law, but rather a warning about how careful and vigilant we must be.

I don't want to scare away any contributor to Scuttlebutt, but rather to encourage original works, both articles and photographs. Taking photos of your own work with your own camera is OK! So are travel photos you take.


**NEW PREMISES FOUND?**

The Course was very successful, and all who attended gained valuable experience to deal with injured persons.

# VICTOR CHANG HEART HEALTH CHECK

On 11th March 2025, 16 members of the Waverley shed attended for testing by the Victor Chang Heart Team.

Cardiovascular disease is the leading cause of death and disability in Australia, claiming the life of one person every 12 minutes. The Victor Chang Heart Health Check identifies issues, and inspires people to act and protect their long-term health. Knowing heart disease risk factors can save life.

The results were mixed, with one or more of the members tested having results outside of the healthy range and being recommended to visit their GP.

Blood sugars were tested, with 15 healthy and 1 elevated; blood pressure was also tested with mixed results; cholesterol tests resulted in 13 healthy, 2 elevated and 1 member high.



# CHANNEL 7 SHOWS OUR BRIGHT SIDE

### **Uniting** War Memorial Hospital Pastoral Care: Community Support and Reflection

For Christians and Jews alike, this season symbolizes God's plan to offer hope and freedom. Passover commemorates the Israelites' rescue from slavery in Egypt, while Easter represents Jesus' sacrificial death and resurrection, offering freedom from suffering with continued life within God's creation. The core message is that nothing can separate us from God's love.

This year, the Pastoral Care team at War Memorial Hospital (WMH), with the support of hospital management, has introduced a couple of initiatives to foster community and support:

- E Hunter Lodge BBQ: Held on the last Wednesday of every month, from 5:30 pm to 7 1. pm, the Pastoral Care team, in partnership with E Hunter Lodge, invites Men's Shed members to join this BBQ. It is a chance to offer support and connect with people from rural areas seeking medical treatment in the city and who may feel isolated.
- 2. "Time with God": Every Monday from 1 pm to 1:30 pm in the Vickery Chapel, there is a 15-minute set aside for hospital visitors, staff and patients to pray, reflect and contemplate God, creation and their spirituality.
- Praise and Worship: On the first Monday of each month, a short time of praise and wor-3. ship is held in the dining room of the rehabilitation wing's second floor, with the help of a local community choir.

The Pastoral Care team is dedicated to providing emotional and spiritual support to those facing difficult transitions or challenging times. These initiatives are designed to create a sense of community and offer comfort during tough moments.



### NEW ZEALAND MARITIME MUSEUM, AUCKLAND

During his recent holiday in New Zealand, Richard Cortis went to the Maritime Museum in Auckland.

### WHAT IS MORE ACCURATE: YOUR SPEEDO OR THE GPS?

The answer is not as simple as it first sounds, it is subject to lots of factors and circumstances. **Speedometer:** Unless you have your speedometer recently custom calibrated, all speedometers in cars manufactured and sold in Australia after 1st July 2006 must comply with Australian Design Rules which strictly provide that your car's speedo **must not show** a speed lower than your actual speed. To avoid liability, therefore, all car manufacturers calibrate the car speedo to show a speed higher than the speed you are actually travelling at.

On an unmodified car, this higher calibration may be just 1kph, but usually it may in fact show a speed of up to 5% higher. This may depend on the model and the manufacturer. If the car is modified by installation of a tyre different to standard, such as a "lower profile tyre" (or the opposite, a "fat pack all terrain tyre") or if your tyre pressure is low (or high) or dependent on the wear on the tyre, your speed as shown on your speedometer may be way out of whack.

This is because the speedo shows the speed calibrated according to the number revolutions of the wheel and any change in the circumference of the tyre compared to the standard circumference as calibrated will not vary the speed shown but does vary the distance travelled (either faster or slower) during a calculated period of time (ie. kilometres per hour).

A good rule of thumb to follow is if your wheels and tyres on your vehicle have a larger rolling diameter, your speedometer will show a slower speed than you are travelling. If you have wheels and tyres with a smaller rolling diameter, your speedometer will show a faster speed than you are actually travelling.

<u>**Global Positioning System (GPS):</u>** GPS speedometers are unregulated by governments. It is accepted that they will in most circumstances show your *actual speed* regardless of the tyre variables discussed above. BUT! There can be a time lag between when a speed is recorded and when it appears in your app such as when you travel on a slope or around winding curves. Also GPS does not work in some tunnels or satellite dead spots, meaning there are timjes when a GPS speedometer does not work at all.</u>

What is important to remember is that when you go downhill, the GPS measures the horizontal distance, even though that distance is just one of the sides of a triangle, and you actually travel the distance made up of the hypotenuse (and therefore you travel a longer distance in that timeframe and therefore travel faster than the speed shown by the GPS!! The reverse is true.

**So, what happens if you are caught by the police "speeding"?** Police use many methods to check the speed of cars travelling on the roads. They use specialised mobile radar units, as well, in all highway patrol cars specially calibrated speedometers are installed, and also, police are trained to make "speed estimates" that the Courts accept as "expert evidence".

As for the radar device and the speedometer used, each different police force in Australia has rules that require regular calibration tests, and tickets issued while using expired tests become inadmissible (but this happens rarer the finding a needle in a haystack). In fact, in most (if not all) jurisdictions the enabling legislation provides that the reading of the radars or specialised speedometers are deemed to be precise and absolute evidence of speed. Even if you prove that your speedo or GPS showed a different speed, it is no defence to the fine as intention is not a relevant factor. Also, even if your car is fitted with a dashcam that takes video that displays your speed as shown on the GPS, it will in most likelihood <u>not be accepted</u> if you decide to fight your speeding infringement notice based on a radar or speedometer checked speed. In the case of a fine based on the "expert evidence" of the estimated speed, only on the very rare occasion will the Court not accept the accuracy of that evidence of estimated speed. As for civil cases where the speed of a car involved in a collision becomes an issue, then such video evidence of speed may be used. Even where the GPS speed is not recorded on the video, there are expert witnesses who can be engaged to estimate the speed of the car by triangulating the car's position to its surroundings shown in the video, but this is really expensive!
